Basic Education: Through our capacity-building program Raise Your Voice, advocates were able to build their skills in advocacy and communication, as well as messaging for decision makers. In 2016, the Alliance Online, our learning platform, connected 164 grassroots advocates from 40 countries. A total of 36 grassroots women's rights organizations from 18 countries took our two online courses Raise Your Voice (advocacy) and Raise Your Visibility (communication).

Economic Opportunity and Trade: We provided capacity building resources to more than 250 organizations to support their advocacy for a wide range of issues. We carried out one-on-one coaching for 20 organizations to support their advocacy work, including our member Rural Women Network of Nepal. After four years of advocating with Alliance members for a global goal on equitable, quality, and inclusive education, we published "Lessons from Collective Advocacy at the United Nations". This report is a roadmap for advocates to engage in global decision-making processes and the importance of women's economic empowerment.

Violence Against Women and Girls: We continue to support Alliance members in their work to end violence against women and girls. In 2016, we launched our #achieveSDG5, a global campaign to ensure grassroots women and girls were not left behind in the implementation of the Sustainable Development Goals. By the end of 2016, more than 300 grassroots women's rights advocates had participated in the social media campaign that delivered messages to decision makers in over 20 countries to end gender-based violence and violence against women and girls. In 2016, we continued to play a leading role in key US-based coalitions working to end gender-based violence and ensure strong policy making in US foreign aid programs.
